Waivers are limited and will be awarded on a priority basis (see below)\*

- The applicant must provide proof of Arizona residency at the beginning of each academic year (example: driver's license; Arizona identification; or Arizona state income tax) and enroll for a minimum of 12 credit hours.
- Students who do not enroll for fall or spring semester or who take less than 12 hours and/or who do not have a 2.5 GPA for priority **one** or a 2.0 GPA for priority **four** at the end of the spring semester, will automatically be out of the program.
- Returning students from ENMU must reapply and submit a student copy of their ENMU transcript by June 15 for the next academic year.
- No waivers will be issued after census date (third Friday from the first day of class).

I hereby certify that I am a permanent resident of Arizona and will not attempt to become a resident of New Mexico while enrolled in the program. If I receive the waiver and decide not to attend ENMU I agree to notify the Office of Enrollment Services prior to registration. I understand that failure to attend ENMU for the designated semester will result in the forfeit of my waiver.

\*The Arizona waiver is restricted to undergraduate students only. Listed below are the priorities in which the applications are reviewed. The priority application deadline is June 15 for the next academic year (fall/spring).

- Priority I Returning ENMU student on the waiver with a cumulative ENMU GPA of 2.5
- Priority II New transfer student with a minimum 2.5 GPA from Pima, Cochise, Eastern Arizona, Northland Pioneer, Central Arizona
- Priority III Arizona resident, first time freshman: 2.5 cumulative high school GPA and a 20 ACT or 940 SAT score or transfer: 2.5 college GPA.
- Priority IV Returning ENMU student on the waiver with less than a 2.5 but no less than a 2.0
