Terms and Conditions

This agreement allows certificate and degree seeking students to receive federal student aid at ENMU-Portales or ENMU-Ruidoso for combined enrollment at two institutions. ENMU will calculate and disburse student's federal student aid awards. All credit hours at each institution must apply to the student's ENMU Portales/Ruidoso degree plan.

- + A consortium agreement is not necessary between ENMU-Portales and ENMU-Ruidoso campuses.
- Students must be enrolled in at least **six** credit hours at ENMU-Portales/Ruidoso for fall/spring terms or **three** hours for the summer term.
- Students must meet all federal student aid eligibility requirements at ENMU-Portales/Ruidoso including satisfactory academic progress.
- Repeated courses must meet aid eligibility requirements to apply to the consortium agreement.
- The number of credit hours at the host institution cannot exceed the number of credit hours at ENMU Portales/Ruidoso.
- Students must meet financial requirements of the host institution, including payment deadlines.
- Complete withdrawal from both ENMU-Portales/Ruidoso and the host institution will result in a return of Title IV funds calculation.
- Complete withdrawal from ENMU Portales/Ruidoso will void the consortium agreement.
- Deadline for completed, signed consortium agreements with required documentation is 5 p.m. on the last day to drop/add for the term.
