

This agreement is between Eastern New Mexico University (University) and the (User) for web page services. The University believes it is necessary to distinguish between the official University web pages, which represent the University system, all campuses, including Portales, Roswell, Ruidoso and any approved learning site, and the non-official web server pages. Non-official web pages include faculty, student and organizations.

- Faculty accounts are for University professors, instructors or other teachers to place professional and instructional content.
- Student accounts are for University students to place personal student-related content.
- Organizational accounts are for University recognized organizations to place organization content.
- All accounts are governed by University policies.

## Web Servers

Official University pages are located on <http://www.enmu.edu> and controlled by the University webmaster. Web services for organization pages are made available through the use of public funds which are provided specifically for educational purposes.

## Terms and Conditions

The web pages served by the University's web services are accessible by Internet users around the world and are subject to all local, state, federal and international law as well as University policies. It is necessary to distinguish between official University pages and separate User pages which may contain opinions and content not directly related to the University.

It is important the obligations of both the User and the University be clearly understood. Therefore, the University and the User, whose signature appears below, agree to the terms and conditions. If the User is a University approved and recognized organization, then the organization shall designate an individual sponsor to be responsible for content on the web server; and the individual sponsor shall acknowledge the terms and conditions and sign it.

- The University shall provide web services to User pursuant to the policies and procedures of the University and the terms and conditions of this Agreement.
- User understands University's computer resources, including the personal Web server and network, is publicly funded; and provided to the User as a privilege.
- All User content shall be the sole responsibility of the User.
- User web pages must prominently display the paragraph provided by the University disclaiming any responsibility for the User's content.
- The following notice shall be inserted at the top of each page: "Notice! This is not an official Eastern New Mexico University web page."
- User content is public and User agrees by posting the pages he or she is making it available to the public.
- CGI-BIN scripts, other than those provided by the University, are not permitted on the web server except for those approved by the campus webmaster and Information Technology Services.
- The University may, due to resource limitations, limit the amount of space provided on the server.
- User pages will be removed from the server no later than one semester after the User leaves the University.
- User pages will only reside on the designated web server. Pages containing links to other machines, within the University's domain, for purposes of displaying personal Web pages shall be disabled. All access from official University web server to the User pages must occur through a common page provided by the University; no direct links are permitted.
- Violation by the User of the terms and conditions of this Agreement may result in the imposition of sanctions. Sanctions include those stated in paragraph 17 of the University Computer Use Policies and Procedures (<http://inside.enmu.edu/page.php?pid=312>), including locking accounts, deletion of content, and revocation of privileges.
