Bachelor of Social Work

The BSW of Social Work is CSWE accredited. Operating within the Department of Health and Human Services in ENMU's College of Liberal Arts and Sciences, our BSW Program follows the standards and guidelines of the Council on Social Work Education (CSWE) to prepare you to be competent, caring, ethical and effective social work practitioners.

Master of Social Work

The MSW program is currently in candidacy status with the Council on Social Work Education (CSWE). We anticipate reaching full accreditation in 2027. While some states will recognize this as appropriate to apply for an MSW or Clinical License, not all states will. It is recommended that students reach out to their social work licensing board in the state where they live to ask if the board will accept programs that are in the candidacy status of the accreditation process.
