Tuition Waivers | **Amount**: waives the difference between in-state and out-of-state tuition.

Arizona Undergraduate Out-of-State Tuition Waiver

Eligibility: be an Arizona resident meeting one of the following priorities:

- Priority I: Returning ENMU student on the waiver with a cumulative ENMU GPA of 2.5 and successfully completed 12 credit hours the previous semester
- Priority II: New transfer students from an Arizona college with a minimum 2.5 cumulative GPA
- Priority III: First-Time Freshman: 2.5 cumulative high school GPA and a 20 ACT or 1030 SAT score
- Priority IV: Returning ENMU with a GPA greater than 2.0

Colorado Scholar Tuition Waiver

Eligibility: be a Colorado resident and have at least a 2.5 cumulative GPA and 20 ACT or 1030 SAT score.

Freshman Competitive Waiver

Eligibility: have at least a 3.5 cumulative high school GPA and 20 ACT or 1030 SAT score **OR** have at least a 3.0 cumulative high school GPA and 23 ACT or 1130 SAT score.

Texas 135-Mile Tuition Waiver

Eligibility: live within 135 miles of ENMU-Portales.

Will I get this scholarship every year?

If you qualify for a one-year freshman academic scholarship, you may receive scholarships for the fall and spring semesters of your freshman year if you complete 15 hours each semester with a minimum GPA of 3.0.

If you qualify for a four-year freshman academic scholarship, it may be renewed for a total of eight consecutive semesters if you complete 15 hours each semester with a minimum GPA of 3.0.

Note: Receipt of any scholarship may affect your eligibility for other financial aid. Scholarships are distributed over two semesters, fall and spring.

How do I apply for a Freshman Academic Scholarship and ENMU Foundation Starter Scholarship?

Submit an ENMU Admission Application. enmu.edu/Apply

Apply for freshman academic scholarship. The deadline for priority consideration is Aug. 1 for fall and Jan. 3 for spring. Applications may be considered until two weeks prior to the beginning of the semester. enmu.edu/ScholarshipsApp

Provide transcripts. Send us a copy of your national ACT/SAT scores and your official high school transcript. enmu.edu/Transcripts

Provide your ACT or SAT test scores. To send your scores to ENMU, use the following codes on your ACT or SAT form: ACT: 2636 | SAT: 4299

Complete your Free Application for Federal Student Aid (FAFSA) application. Submit the FAFSA before the semester begins; you can submit online starting in October of your senior year. Eastern's FAFSA school code is 002651. FAFSA.ed.gov

Register for classes. Enroll in at least 15-credit hours at ENMU-Portales campus.
